Emergency Procedures

Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. As a water based product, if spilt on electrical equipment the product will cause short-circuits.

7. HANDLING AND STORAGE

Precautions for Safe Handling
