### 4. FIRST-AID MEASURES

**Inhalation**

## 5. FIRE-FIGHTING MEASURES

**Suitable Extinguishing Media**

Use appropriate fire extinguisher for surrounding environment.

**Specific Hazards Arising From The Chemical**

This product is non combustible. However, following evaporation of aqueous component under fire conditions, the non-aqueous component may decompose and/or burn.

**Precautions in connection with Fire**

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency Procedures**

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Spillage can be slippery. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

## 7. HANDLING AND STORAGE

**Precautions for Safe Handling**

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene by washing hands prior to eating, drinking, smoking or using toilet facilities.

**Conditions for safe storage, including any incompatibilities**

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Protect from freezing. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Occupational exposure limit values**

No exposure standards have been established for the mixture. However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.

**Biological Limit Values**

### Appropriate Engineering Controls

Use with good general ventilation. If mists or vapours are produced, local exhaust ventilation should be used.

### Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable mist/vapour filter should be used. ### Eye Protection

Safety glasses with side shields, full face shield or chemical goggles should be worn. Final choice of appropriate eye/face protection will vary according to individual circumstances.
