## 6. ACCIDENTAL RELEASE MEASURES

**Emergency Procedures**

## 7. HANDLING AND STORAGE

**Precautions for Safe Handling**

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. Washing hands prior to eating, drinking, smoking or using toilet facilities.

**Conditions for safe storage, including any incompatibilities**

Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers tightly closed.

Store at room temperature (15-25°C recommended).
