**Personal precautions, protective equipment and emergency procedures** Slippery when spilt - avoid accidents. Wear appropriate personal protective equipment and clothing to minimise exposure. ## 7. Handling and storage

**Precautions for Safe Handling** Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. ## 8. Exposure controls/personal protection

**Occupational exposure limit values** No exposure standards have been established for this material by Safe Work, Australia. However, over-exposure to some chemicals may result in enhancement of pre-existing adverse medical conditions and/or allergic reactions and should be kept to the least possible levels.
