4. FIRST-AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Extinguish or remove all sources of ignition and stop leak if safe to do so. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Place inert absorbent, Non combustible material onto spillage. 7. HANDLING AND STORAGE

Precautions for Safe Handling

Have emergency equipment (for fires, spills, leaks, etc.) readily available. Work from suitable, labelled, fire-resistant containers. Open containers carefully as they may be under pressure. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. Ensure that storage conditions comply with applicable local and national regulations. Appropriate Engineering Controls
